

APPLICATION FOR MEMBERSHIP

The undersigned (hereinafter called ("Applicant") hereby applies for membership in and agrees to purchase electric energy from VICTORIA ELECTRIC COOPERATIVE, INC. (hereinafter called "Cooperative") upon the following terms and conditions:

- 1. Applicant will pay cooperative the sum of \$5.00 which, if this application is accepted by the Cooperative, will constitute the Applicant's membership fee.
2. Applicant will, when electric service becomes available, purchase from Cooperative electrical energy used on the premises described in the application for electric service and will pay therefore monthly, or otherwise as specified in the application for electric service; provided that the Cooperative may limit the amount of electrical energy furnished for industrial uses. Applicant will pay the minimum bill prescribed in the application for electric service, regardless of the number of kilowatt hours consumed.
3. Member's Installation, Member warrants that his or her installation at the Service Location including all conductors, switches, equipment, wiring, and protective devices of any kind or character is constructed in accordance with National Electrical Safety Code for the American Standards Association as well as applicable laws or ordinances, and that member's Installation will maintained in such a manner as to confirm to such standards.
4. Applicant will comply with and be bound by the provisions of the Articles of Incorporation and Bylaws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Cooperative.
5. Applicant, by paying a membership fee and becoming a Member, assumes no personal liability for responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law, Applicant's private property is exempt from execution for any such debts or liabilities.
6. Easements and Right of Access. Customer agrees to grant or to secure for Cooperative, at Member's expense, any rights of way on property owned or controlled by Member and to provide suitable space on such premises for installation of facilities where such rights of way and space are necessary to provide electric service to Member. Cooperative's representatives, employees, and assigns are hereby granted rights of Ingress and Egress of Customer's premises at all reasonable times for the purpose of Inspection of facilities, trim or clear easement right-of-way, providing service, and in order to carry out the provisions hereof.
7. Acceptance of this application by Cooperative shall constitute an agreement between Applicant and Cooperative for the purchase and sale of electric energy according to the terms of the application for electric service hereafter executed by Applicant.
8. Applicant understands and agrees that Applicant will not become a Member of Cooperative unless and until accepted expressly accepted by the Board of Directors or the members of the Cooperative, and that this application for membership will not be accepted unless Applicant further executes and submits an application for electrical service on the forms prescribed by the Cooperative, setting forth the terms of his agreement to purchase electrical energy.
9. If Applicant, after electric service is available, falls for any reason whatsoever to receive electric energy for a consecutive period of more than one year, then Applicant hereby agrees that such failure shall be Applicant's request that said membership in Cooperative be forthwith terminated.
